Dear parent/guardian,

Hampton Primary School is looking forward to a wonderful year ahead of on-site teaching and learning and as such, we are advising you of the school's voluntary financial contributions for 2022.

Schools provide students with free instruction to fulfil the standard Victorian Curriculum and therefore all contributions are voluntary. Nevertheless, these contributions from our families ensure that our school can offer the best possible education and support for your children. We thank you for your ongoing support, both in financial contributions and through fundraising or volunteering your time. Together, these make a significantly positive difference to our school and the programs we can offer.

Within our school this support has allowed us to make capital improvements, such as install a new playground, indigenous garden, refurbish toilets and re-carpet classrooms. It also allows us to conduct highly valued programs such as specialist classes, inter-school activities, STEAM activities, iPads throughout the school and more. While the Department of Education and Training funds a standard curriculum program, these programs and resources provided by Hampton Primary School go above and beyond this funding and could not be provided without your financial support. For families experiencing hardship, more information on supports available can be found on page 5 of this letter.

Some of our school improvement projects currently underway and for the future include:

- Creating a dedicated breakout meeting room for students
- Enhancement of the professional learning program for staff
- Extensive repainting and refurbishment of the main building that houses 12 classes.
- Re-carpeting of classrooms
- Creating a dedicated STEAM facility
- Re-surfacing the main quadrangle of the school for assemblies and student gatherings
- Purchasing additional literacy materials including new readers for students from Foundation to Grade 6
- Enacting key aspects of our Reconciliation Action Plan
- Upgrading and maintaining technology hardware

These priorities will continue to enable Hampton Primary School to provide an education of relevance in the 21st Century and achieve exceptional results for your children.

Refunds

Refunds will be worked out on a case-by-case basis. Hampton Primary School has the discretion to provide refunds to families and will do so where it is reasonable and fair (for example, if the school has not incurred a cost).

If the school has incurred costs, the school will act reasonably and take into consideration the Financial Help for Families Policy and relevant arrangements, including support for families experiencing hardship. For example, the schools will consider refunding families for unavoidable event cancellations if a family experiences a crisis or sudden serious illness and the student can no longer attend the event (and a medical certificate is provided).

When the school provides a refund, the family will need to advise their bank account details in writing and the funds will be electronically transferred.

FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
